ORDER:

As per the recommendations of statute on affiliation of colleges of Nursing adopted by the Executive Council of Dr.YSR UHS in October, 1996 and as amended in July, 2003 and as per the orders of the Vice Chancellor, Dr. YSR UHS, Vijayawada, in the reference 12th cited, it is hereby certified that the application of **JMJ College of Nursing, St. Theresa's Hospital Premises, NR Pet, Kurnool** sponsored by **Society of Jesus Mary Joseph, 6-3-900, Somajiguda, Hyderabad, Telangana State** for starting of **B.Sc.(Nursing) 4 years Course** has been registered with Dr.YSR University of Health Sciences, Vijayawada and the **Provisional Affiliation** is granted to **JMJ College of Nursing, Kurnool** for **starting of 1st year B.Sc.(Nursing) 4 YD Course** and for admitting students with an intake of **60 (Sixty)** for the academic year **2022-23**, **subject to final orders of the Supreme Court of India regarding submission of renewal of recognition/permission from Indian Nursing Council, New Delhi for the academic year 2022-23.**

Conditions :

1. Shall obtain permission of the APNMC, Vijayawada every year.
2. The Physical facilities, clinical facilities, teaching and other staff should be as per the Norms of Indian Nursing Council, New Delhi and as per Dr.YSR UHS Statutes.
3. Dr.YSR UHS may conduct surprise inspections at any time for verification of college facilities.
4. In case if any of the information furnished by the Institution is false or misleading the University has a right to withdraw the permission without further notice.

5. Should upload the attendance of all admitted students “online” through Biometric devices compulsorily.
6. Should get mandatory registration of all the students admitted and undergoing Nursing Course, into Digital Library and NTRMEDNET Consortium and submit the list of candidates registered, to the University and Remote XS.
7. Should upload the data of admitted students to APSCHE and AISHE portals every year as per the time frame given by the APSCHE.

Further the Principal of the institution is fully responsible to fulfill and maintain norms including the infrastructure both physical and human resource, teaching faculty and clinical facilities etc., throughout the academic year, as stipulated in Regulation of INC, New Delhi/ Statutes of Dr.YSR UHS, Vijayawada.

The Principal/College management is here by informed that, in the event of non participation in University C.Q quota counselling the college can only fill seats allotted to Management Quota (40% of total intake) Subject to receipt of Fee fixation G.O, before the closure of Admission schedule for 2022-23. Management cannot fill CQ quota seats under any circumstances.

The Number of students admitted shall not exceed the number of students permitted for annual admissions both under University and Management quota as specified by the Indian Nursing council / Dr.YSR UHS.

The fee collected by what so ever name called either for University quota seats or for Management seats should not exceed the limits specified by the State Government / Dr.YSR UHS from time to time.

The Management of the college shall follow the regulations made by the Government of Andhra Pradesh/Dr.YSR University of Health Sciences/Indian Nursing Council in making admissions, in conducting examinations and in respect of all other related matters from time to time. Any violations in this regard may lead to disaffiliation of the college without any notice.
